Daycare only = no overnight stay

Boarding = Overnight Stay

Small Dog = Dogs under 30 lbs and unable to jump 30" fences

Med/Large Dog = All other dogs

Isolation Suite = No Daycare Play with overnight stay includes a)small dogs with dietary restrictions,
b)small dogs unable to play in daycare, or c)owner requested

Unscheduled drop off or pick up = any date other than the date specified with reservation without at least 4 hours notification by phone (voicemail is acceptable)

Daycare: \$15/dog per day or 10 day pass for \$120

Small Dog Boarding: \$20 per night per dog

Unneutered Small Dog: \$27 per night per dog

Isolation Suite Small Dog: \$23 per night per dog

Med/Large Dog Boarding: \$30 per night per dog

Additional Fees

Your pet(s) will be checked for fleas within the first 30 minutes of arrival. If fleas are found, your pet(s) will be administered a CAPSTAR at owner's cost (\$ 7.50/pet--price subject to change w/o notice)

Aggressive or dogs able to jump 6 ft fences = \$5 additional charge per night

Unscheduled Pick up or Drop off Fee \$25

No Call; No Show Fee \$25 per dog

Liability

Gupton Pet Care Center--Gupton PCC (official corporate name: Gupton's Pets & Supplies, Inc.) and their owners, employees, and agents shall not be liable for any damages to the animal arising out of or from the boarding or grooming of the animal, or that may accrue from any cause in connection with boarding or grooming including loss by fire, theft, running away, death, or injury during the terms of this agreement, whether the animal is on the premises of Gupton PCC or not, except where the loss is caused by gross negligence of Gupton PCC, or its owners, employees, or agents.

Owner shall be solely responsible for all of the acts of the animal(s) at any time during the terms of this agreement, and in no case shall Gupton PCC be liable for the animal's acts and behavior other than for the exercise of gross negligence on the part of Gupton PCC in the boarding/grooming and keeping of the animal. Owner shall indemnify Gupton PCC from and against any and all damages sustained or suffered by reason of the boarding or grooming of the animal for any claims or injuries arising out of the boarding or grooming of the animal except where the injury is caused by the gross negligence of Gupton PCC, its owners, employees, or agents

Owner agrees that Gupton PCC will not be held responsible for aggravation of any pre-existing medical conditions, including but not limited to heart disease, arthritis, obesity, infections and any other conditions that might be discovered by examination.

Owner agrees that Gupton PCC does not assume and shall not be held responsible for the loss and/or destruction of personal belongings left with the pet while boarding or grooming including but not limited to bedding, toys, dishes, collars, tags, leashes, clothing, and food

Owner agrees that complimentary bathes are given at the discretion of Gupton PCC staff and are not a required service covered under the boarding fees.

Owner agrees to provide written instructions for the treatment of an ailing pet (very old or with major health concerns) that passes while under the care of Gupton PCC. This includes but is not limited to treatment of the remains and the timing of contact of the owner to report the passing

Owner agrees that drop off and/or pick up of their pet will occur on the reserved date(s) only during the times specified below and understands that the door to the facility remain locked to incoming and outgoing clients except during the times specified below

Monday: 8-10am or 4-6pm
Tuesday: 7-10am or 4-6:50pm
Wednesday: 7-10am or 4-6:50pm
Thursday: 7-10am or 4-6:50pm
Friday: 7-10am or 4-6:50pm
Saturday: 7-10am or 4-6:50pm
Sunday: 8-10am or 4-6pm

Animals in a group situation, such as boarding, grooming, dog parks, training, etc. are exposed to common illnesses, similar to that of humans. Owner agrees to assume the risks and hazards that may be expected to arise from interaction with other animals.

Illness/Injury of Animal:

In case of illness or injury, owner gives consent for the staff of Gupton Pet Care Center-- Gupton PCC (official corporate name: Gupton's Pets & Supplies, Inc.) to administer first aid. If the severity of the illness or injury require veterinary care, the owner shall be notified as soon as possible at the above listed phone numbers. However, if Gupton's is unable to reach owner or if owner does not immediately inform Gupton's regarding measures to be taken, or if the animal's health requires emergency action, owner grants Gupton's the right to send pet to the Veterinary clinic of Gupton's choice to treat said injury or illness. Owner consents for the attending vet to prescribe, treat, or operate on pet(s) while they are being boarded or groomed at Gupton PCC addition, the attending vet may send pet(s) to the emergency clinic after hours for intensive care, monitoring, and/or treatment at his/her discretion, and any expenses incurred in conjunction with such care is owner's responsibility and shall be promptly paid by owner.

Owner agrees that Gupton PCC does not and shall not be held responsible for any costs, damages, claims, or expenses arising from any injury or illness during or after a boarding or grooming visit.

Owner agrees that (his/her) pet may change sleeping, eating, drinking, and activity level for several days after boarding due to the change in daily routine. Owner agrees not to hold Gupton's liable for any illness or ailment that may affect (his/her) pet if (his/her) pet becomes

ill during or after its visit and owner agrees to indemnify and hold Gupton PCC harmless for any costs, damages, claims or expenses arising there from.

Owner shall pay all charges and costs associated with boarding and/or grooming and for all veterinary and medical costs that may be incurred during the terms of this agreement for the animals listed above.

This document will remain valid until cancelled in writing or replaced
